This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director, entered December 14, 1994, at Special Order Volume 48, Page 377, approving Transfer 664, and supersedes Certificate 39929, State Record of Water Right Certificates.
