A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The use shall conform to any reasonable rotation system ordered by the proper state officer.


The storage of water under this right is limited to 63.9 acre feet each, regardless of the number of existing or future secondary uses from the reservoir.

This certificate is issued to confirm a change in CHARACTER OF USE approved by an order of the Water Resources Director, entered March 9, 1995, at Special Order Volume 49, Page 105, approving Transfer 6648, and together with Certificate 68448, supersedes Certificate 40454, State Record of Water Right Certificates.

The right to store and use the water for the above purpose is restricted to beneficial use at the place of use described.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
