CERTIFICATE OF WATER RIGHT

Confirms the right to use the waters of the NORTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATION of 38.12 acres.

This right was perfected under Permit 26192. The date of priority is MAY, 15, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.48 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion form the source.

The point of diversion is located as follows:

SE 4, SE 4 of SECTION 22, TOWNSHIP 26 SOUTH, RANGE 6 WEST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2 ½ acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to the use is limited to the period when flow of water in the North Umpqua River is 525 CFS or more at its mouth.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
