CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Touchet, WA 99360

confirms the right to use the waters of PINE CREEK, a tributary of WALLA WALLA RIVER, for SUPPLEMENTAL IRRIGATION of 122.0 acres.

This right was perfected under Permit 520. The date of priority is NOVEMBER 26, 1910. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.53 CUBIC FEET PER SECOND or its equivalent in case of rotation. The use shall conform to any reasonable rotation system ordered by the proper state officer.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
