CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

S. C. Weathermon, H. C. Gee and Herbert March

confirms the right to use the waters of TWO SPRINGS and WASTE WATER in the NW¼, SW¼, SE¼ NE¼, and NW¼ SE¼, Section 24, Township 6 North, Range 34 East, W.M., a tributary of WALLA WALLA RIVER, for PRIMARY IRRIGATION OF 6.0 acres and SUPPLEMENTAL IRRIGATION of 69.4 acres.

This right was perfected under Permit 12221. The date of priority is June 10, 1936. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.94 CUBIC FOOT PER SECOND, being 0.23 cubic foot per second from springs and 0.71 cubic foot per second from waste water, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and is also limited to the water available at the proposed point of diversion, and does not carry with it the right to require the wasteful use of water by others, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 12262, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered March 26, 2008 approving a petition by Hudson Bay District Improvement Company under ORS 541.329 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
