CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of DUGGER CREEK, a tributary of PINE CREEK, for STOCK AND SUPPLEMENTAL IRRIGATION of 37.52 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 3, at Page 321. The dates of priority are 1890 for 5.31 acres, 1894 for 3.55 acres, 1900 for 20.99 acres, and 1908 for 7.67 acres.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.47 cubic foot per second from May 1st to September 1st of each year, or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


A description of the place of use to which this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate confirms an order of the Water Resources Director entered on March 26, 2008, and recorded in Special Order Volume 74, Page 455, approving a petition by Hudson Bay District Improvement Company under ORS 541.329 for mapping water rights within a district. This certificate, along with 83918, supersedes water right Certificate 81806.
