## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Hudson Bay District Improvement Company P.O. Box 110 Milton-Freewater, OR 97862

confirms the right to use the waters of LITTLE WALLA WALLA RIVER, a tributary of WALLA WALLA RIVER, for IRRIGATION of 59.47 acres.

This right was perfected under Permit S-1216. The date of priority is MAY 3, 1913. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.74 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
