CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOUIS JAMES HOPKINS

SEATTLE, WA 98133

confirms the right to use the waters of A WELL in the EAST MUD CREEK (PINE CREEK) BASIN for PRIMARY IRRIGATION of 21.95 and SUPPLEMENTAL IRRIGATION of 14.80 ACRES.

This right was perfected under Permit G-2268. The date of priority is SEPTEMBER 20, 1962. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.46 cubic foot per second, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

6 N	35 E	WM	20	NE SW	600 FEET NORTH AND 960 FEET EAST FROM THE SW CORNER, NE SW, OF SECTION 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:


This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate confirms an order of the Water Resources Director entered on **MAR 26 2008**, and recorded in Special Order Volume 74, Page ~~455~~ approving a petition by Hudson Bay District Improvement Company under ORS 541.329 for mapping water rights within a district. This certificate supersedes water right Certificate 33376.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
