CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Hudson Bay District Improvement Company P.O. Box 110 Milton-Freewater, OR, 97862

confirms the right to use the waters of the LITTLE WALLA WALLA RIVER and TUM-A-LUM BRANCH OF WALLA WALLA RIVER, tributaries of WALLA WALLA RIVER, for PRIMARY IRRIGATION of 464.10 acres and SUPPLEMENTAL IRRIGATION of 32.2 acres.

This right was perfected under Permit S-32145. The date of priority is February 15, 1967. The amount of water to which this right is entitled is limited to not more than 10.3 CUBIC FEET PER SECOND WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM LITTLE WALLA WALLA RIVER TO BE MADE UP BY APPRORIATION FROM TUM-A-LUM RIVER PROVIDED THE TOTAL QUANTITY DIVERTED FROM BOTH SOURCES DOES NOT EXCEED 10.3 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the sources.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN, PROVIDED FURTHER THAT THE RIGHT ACQUIRED HEREIN TOGETHER WITH THAT UNDER ALL OTHER RIGHTS HELD BY THE COMPANY TO THE USE OF THE LITTLE WALLA WALLA AND TUM-A-LUM RIVERS SHALL NOT EXCEED THE CAPACITY OF THE DIVERSION WORKS AT TIME OF MAKING PROOF OF APPROPRIATION.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
