## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL #1 in the UMATILLA BASIN for SUPPLEMENTAL IRRIGATION OF 73.15 ACRES.

This right was perfected under Permit G-7914. The date of priority is DECEMBER 14, 1977. This right is limited to an amount beneficially used and shall not exceed 0.18 cubic foot per second or its equivalent in case of rotation, measured at the point of appropriation.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use of water shall be limited when it interferes with the prior water rights of others.

A description of the place of use to which this right is appurtenant is as follows:
