## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Sara and Jonathan Hellberg-Wilson 1044 Rainville Road Lowden, WA 99360

confirms the right to use the waters of South Branch of Mud Creek, a tributary of WALLA WALLA RIVER, for POWER AND SUPPLEMENTAL IRRIGATION of 62.3 acres (supplemental irrigation during the irrigation season).

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 1, at Page 113. The dates of priority are 1890 for 37.0 acres, 1900 for 25.3 acres, and 1909 for the generation of two horse-power.

The use is limited to 0.46 cubic foot per second for 1890, 0.32 cubic foot per second for 1900, and 1.8 cubic feet per second for 1909, or its equivalent in case of rotation, measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

This certificate confirms an order of the Water Resources Director entered on March 21.2003 and recorded in Special Order Volume 74, Page 455 approving a petition by Hudson Bay District Improvement Company under ORS 541.329 for mapping water rights within a district. This certificate supersedes water right Certificate 39.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
