CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LITTLE WALLA WALLA RIVER and the WALLA WALLA RIVER, tributaries of the COLUMBIA RIVER, for IRRIGATION of 966.2 acres and SUPPLEMENTAL IRRIGATION of 90.90 acres.

This right was perfected under Permit 16218. The date of priority is MARCH 27, 1945. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 39.64 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to 0.0375 of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
