 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HUDSON BAY DISTRICT IMPROVEMENT CO.

confirms the right to use the waters of the LITTLE WALLA WALLA RIVER, a tributary of the WALLA WALLA RIVER, for IRRIGATION of 297.97 acres.

This right was perfected under Permit E-170. The date of priority is MAY 3, 1913. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 3.09 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at point of diversion from the stream.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
