CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W. J. MARTIN 2934 JUMPOFF JOE CREEK ROAD GRANTS PASS OREGON 97526

confirms the right to use the waters of JACK CREEK, A TRIBUTARY OF JUMP OFF JOE CREEK, for IRRIGATION of 17.0 ACRES.

This right was perfected under Permit 47792. The date of priority is APRIL 28, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.21 CUBIC FOOT PER SECOND, if available at the original point of diversion in the NE¼ NW¼, SECTION 32, T 34 S, R 5 W, WM; 1580 FEET NORTH AND 1910 FEET EAST FROM THE W¼ CORNER, SECTION 32, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, together with the quantity diverted at the original point of diversion, shall not exceed the quantity of water available at the original point of diversion.

When in the judgment of the Watermaster it becomes necessary, the water user shall install and maintain a headgate, an inline flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Watermaster prior to beginning of construction and the weir or measuring
