This right was perfected under Permit S-298. The date of priority is JULY 26, 1909. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.007 CUBIC FOOT PER SECOND, if available at the old point of diversion: LOT 4 (NW¼ SE¼), SECTION 17, T35S, R1W; 960 FEET SOUTH AND 3370 FEET EAST FROM THE W¼, SECTION 17, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

Water shall be acquired from the same surface water source as the original point of diversion.

This certificate describes that portion of the water right confirmed by Certificate 83466, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered <u>April 25, 2008</u>, approving Transfer Application T-9552.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
