CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RRIP LLC 7196 DURANGO ST LAS VEGAS NV 89120

confirms the right to use the waters of A SLOUGH, tributary to the ROGUE RIVER for SUPPLEMENTAL IRRIGATION of 3.7 ACRES.

This right was perfected under Permit 23998. The date of priority is DECEMBER 9, 1955. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.046 CUBIC FOOT PER SECOND, if available at the original point of diversion located in LOT 6 (SW¼ NW¼), SECTION 6, T 36 S, R 1 W, W.M.; PORTABLE PUMPING FROM SLOUGH BETWEEN POINTS LOCATED 1740 FEET SOUTH AND 1010 FEET EAST; AND 2630 FEET SOUTH AND 610 FEET EAST; FROM THE NW CORNER, SECTION 6, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain the fish screen or by-pass device.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered October 22, 2001, at Special Order Volume 55, Page 1145, approving Transfer Application 8266, and together with Certificate 78139, supersedes Certificate 36484, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
