## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Tim M. and Linda L. Deruwe 412 Gardena Creek Road Touchet, WA 99360

confirms the right to use the waters of PINE CREEK, a tributary of WALLA WALLA RIVER, for SUPPLEMENTAL IRRIGATION of 122.0 acres.

This right was perfected under Permit S-520. The date of priority is NOVEMBER 26, 1910. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.53 CUBIC FEET PER SECOND or its equivalent in case of rotation. The use shall conform to any reasonable rotation system ordered by the proper state officer.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
