CERTIFICATE OF WATER RIGHT

confirms the right to use the LITTLE WALLA WALLA RIVER, a tributary of the WALLA WALLA RIVER, for SUPPLEMENTAL IRRIGATION OF 934.77 acres.

This right was perfected under Permit S-26001. The date of priority is JANUARY 16, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 23.44 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 0.0375 of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
