CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CROOKED RIVER, tributary of the DESCHUTES RIVER, for IRRIGATION of 17.8 ACRES and SUPPLEMENTAL IRRIGATION OF 11.5 ACRES.

This right was perfected under Permit 26748. The date of priority is APRIL 29, 1960 for 0.31 CFS and MAY 24, 1960 for 0.14 CFS. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.45 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.
