A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of AN UNNAMED STREAM, a tributary of MILL CREEK, for the purpose of SUPPLEMENTAL IRRIGATION of 15.0 ACRES.

This right was perfected under Permit 47834. The date of priority is MAY 27, 1983. This right is limited to 0.20 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 22, T 3 S, R 40 E, W.M.; 2920 FEET NORTH
AND 730 FEET WEST FROM THE SE CORNER, SECTION 22.

A description of the place of use to which this right is appurtenant is as follows:


SW 1/4 NW 1/4 3.5 ACRES
NW 1/4 SW 1/4 11.5 ACRES
SECTION 23
TOWNSHIP 3 SOUTH, RANGE 40 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered on April 13, 1998, approving Transfer Application T-7938, and supersedes Certificate 65902, State Record of Water Right Certificates. This certificate corrects a scrivener's error in Certificate 82278 describing the place of use of water under the right. This certificate supercedes Certificate 82278.
