CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DICKMAN FARMS, INC. 15829 MT ANGEL-SCOTTS MILLS HIGHWAY NE SILVERTON OR 97381

confirms the right to use the waters of BUTTE CREEK, a tributary of the PUDDING RIVER, for IRRIGATION of 40.5 ACRES.

This right was perfected under Permit 39747. The date of priority is JULY 11, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.51 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered July 13, 2007, at Special Order Volume 72, Page 622, approving Transfer Application 9889, and supercedes Certificate 74273, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
