CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STRAUS RANCHES
10613 TABLE ROCK RD.
CENTRAL POINT, OR 97502

confirms the right to use the waters of an UNNAMED STREAM 1 WHEN AVAILABLE, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM UNNAMED STREAM 1 TO BE MADE UP BY APPROPRIATION FROM STREAM 2, tributaries of LITTLE BUTTE CREEK, for IRRIGATION of 3.5 ACRES and SUPPLEMENTAL IRRIGATION of 23.58 ACRES.

This right was perfected under Permit S-48316. The date of priority is JANUARY 10, 1984. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.34 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH, ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate describes that portion of the water right confirmed by Certificate 66056, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 26 2008, approving Transfer Application T-8513.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
