CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CROOKED RIVER, tributary to DESCHUTES RIVER, for IRRIGATION of 252.4 ACRES.

This right was perfected under Permit S-320. The date of priority is JUNE 1, 1910. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.16 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
