## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELSINORE DEVELOPMENT GROUP, LLC 19480 SW 97<sup>TH</sup> AVE. TUALATIN, OR 97062

confirms the right to use the waters of AN UNNAMED STREAM and SPRINGS, tributaries to the WILLAMETTE RIVER for SUPPLEMENTAL IRRIGATION of 20.0 acres.

This right was perfected under Permit S-11502. The date of priority is NOVEMBER 13, 1934. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.25 CUBIC FOOT PER SECOND (cfs), being 0.125 cfs from each source, or its equivalent in case of rotation measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

This certificate confirms the right modified by provisions of an order of the Water Resources Director entered <u>OCTOBER</u> 30, 2008, and recorded at Special Order Volume 75, Pages 578-579, approving a diminution of the right evidenced by Certificate 11637, State Record of Water Right Certificates. This certificate supersedes Certificate 11637.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
