confirms the right to use the waters of LITTLE BUTTE CREEK, tributary to ROGUE RIVER for IRRIGATION of 10.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 498. The dates of priority are 1885 for Tract 1 and 1908 for Tract 2

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.135 CUBIC FOOT PER SECOND (CFS), being 0.04 CFS for Tract 1 and 0.095 CFS for Tract 2, if available at the original points of diversion, the Tucker and Bieberstedt Ditches, from April 1 to October 1, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use to which this right is appurtenant is as follows:

Water shall be acquired from the same surface water source as the original point of diversion

The quantity of water diverted at the new point of diversion, together with that appropriated at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device in accordance with Oregon Department Fish and Wildlife specifications.


NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered January 10, 2002, at Special Order Volume 56, Page 40, approving Transfer Application 8829, and together with a portion of Certificate 81571, supersedes Certificate 17163, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.
