## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARK AND JOLLY KRAUTMANN 4194 71ST AVENUE SE SALEM OREGON 97301

confirms the right to use the waters of NORTH SANTIAM RIVER, a tributary of the SANTIAM RIVER, for IRRIGATION of 24.1 ACRES.

This right was perfected under Permit 31614. The date of priority is MAY 25, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.30 CUBIC FOOT PER SECOND, if available at the original point of diversion located in LOT 3 (NE¼ NW¼), SECTION 22, T 9 S, R 1 E, WM; 480 FEET SOUTH AND 1300 FEET EAST FROM THE SW CORNER, DLC 49, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water new point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

When required by the Department, the water user shall install and maintain a head gate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same surface water source as the original point of diversion.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director, entered December 8, 1997, at Special Order Volume 51, Page 1346, approving Transfer Application 6870, and supersedes Certificate 64092, State Record of Water Right Certificates.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
