CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of DETROIT RESERVOIR, constructed under Permit R-1625, tributary of the NORTH SANTIAM RIVER, for SUPPLEMENTAL IRRIGATION of 43.6 ACRES.

This right was perfected under Permit 47553. The date of priority is FEBRUARY 11, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 109.0 ACRE OF FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract No. 3-07-10-W0476, or a satisfactory replacement, between the Bureau of Reclamation and the water user, a copy of which is on file in the records of the Water Resources Department. This right is limited to any deficiency in the available supply of any prior right existing for the same land.
