CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

AVION WATER CO. INC. 60813 PARRELL RD BEND OR 97702

confirms the right to use the waters of WELLS 1 AND 3 in the Deschutes River Basin for GROUP DOMESTIC USE FOR 80 FAMILIES INCLUDING THE IRRIGATION OF LAWN AND GARDEN NOT TO EXCEED ONE-HALF ACRE FOR EACH.

This right was perfected under Permit G-9999. The date of priority is JUNE 11, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a total of 0.27 CUBIC FOOT PER SECOND (CFS), BEING 0.18 CFS FROM WELL 1 AND 0.11 CFS FROM WELL 3 IN ANY COMBINATION, or its equivalent in case of rotation, measured at the wells. Provided the total quantity of water appropriated from Well 1 between this right and the right developed under permit G-8258 does not exceed 0.22 CFS; further provided that the total quantity of water appropriated between the two rights does not exceed 0.31 CFS.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

The water user shall install and maintain a weir, meter, or other suitable measuring device and keep a complete record of the amount of ground water withdrawn.

The use of water shall be limited when it interferes with any prior surface or ground water rights.
