CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EDWARD J. COOLEY P.O. BOX 642 ELKTON, OR 97436

confirms the right to use the waters of MEHL CREEK AND AN UNNAMED STREAM, tributaries of the UMPQUA RIVER, for PRIMARY IRRIGATION OF 4.8 ACRES.

This right was perfected under Permit 46290. The date of priority is AUGUST 12, 1980. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.059 CUBIC FOOT PER SECOND FROM MEHL CREEK WHEN AVAILABLE WITH ANY DEFICIENCY IN SUPPLY AT MEHL CREEK TO BE MADE UP BY DIVERSION OF WATER FROM THE UNNAMED STREAM, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen or fish by-pass device.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 26, 2002, at Special Order Volume 56, Page 258, approving Transfer Application 8568, and together with Certificate 79461, supercedes Certificate 74501, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
