CERTIFICATE OF WATER RIGHT.

(For rights which have been confirmed by the Courts)

THIS IS TO CERTIFY, That the SQUAW CREEK IRRIGATION COMPANY, a corporation, of Prineville, State of Oregon, has a right to the use of the waters of SQUAW CREEK, a tributary of the Deschutes River, in Crook County, Oregon, for the purposes of irrigation during the irrigation season and domestic use throughout the year, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume I, at Page 471; that the priority of the right hereby confirmed dated from November 11, 1895 for the irrigation of 2864.5 acres, and from 1904, for the irrigation of 2411.5 acres; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 57.29 cubic feet per second as of date November 11, 1895; 43.23 cubic feet per second as of date 1904.
