confirms the right to use the waters of LITTLE BUTTE CREEK, tributary to ROGUE RIVER for IRRIGATION of 20.11 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 498. The date of priority is 1885 for Tract 1 and 1908 for Tract 3.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.251 CUBIC FOOT PER SECOND (CFS), being 0.122 CFS for Tract 1 and 0.129 CFS for Tract 3, if available at the original point of diversion, Tucker Ditch, from April 1 to October 1, or its equivalent in case of rotation, measured at the point of diversion.

Water shall be acquired from the same surface water source as the original point of diversion

The quantity of water diverted at the new point of diversion, together with that appropriated at the other points of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or fish by-pass device in accordance with Oregon Department Fish and Wildlife
