CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHILIP R. OLSON
23725 OLD BETHEL ROAD

confirms the right to use the waters of UNNAMED DRAINAGEWAY AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6642, tributary to ASH SWALE, for SUPPLEMENTAL IRRIGATION OF 231.7 ACRES.

This right was perfected under Permit S-41972. The date of priority is SEPTEMBER 30, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.90 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-6642, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
