CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORPAC FOODS INC.

confirms the right to use the waters of FIVE WELLS, tributaries to WILLAMETTE RIVER for FOOD PROCESSING.

This right was perfected under Permit G-6014. The date of priority is OCTOBER 2, 1973, FOR 0.2 CUBIC FOOT PER SECOND (CFS), AND DECEMBER 13, 1973, FOR 0.7 CFS FROM WELLS 1 AND 3. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.9 CFS, if available at the original points of appropriation: BEING WELL 1: NE¼ NE¼, 350 FEET SOUTH & 350 FEET EAST; WELL 3, SE¼ NE¼, 530 FEET SOUTH & 50 FEET EAST; WELL 4, SE¼ NW¼, 470 FEET SOUTH & 1750 FEET WEST, AS PROJECTED WITHIN COOPER DLC 53, ALL FROM THE NW CORNER OF THE SE¼ NE¼, SECTION 9, T 5 S, R 3 W, W.M., measured at the wells.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original points of appropriation.

When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered June 24, 1992, at Special Order Volume 46, Page 315, approving Transfer Application 6500, and supercedes Certificate 47352, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
