 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of JACK CREEK, tributary to METOLIUS RIVER for IRRIGATION of 2.9 ACRES.

This right was perfected under Permit 15311. The date of priority is May 16, 1941. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.05 cubic feet per second, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion (POD) are located as follows:

ORIGINAL	12 S	9 E	WM	31	SE NE	170 FEET NORTH & 700 FEET WEST FROM THE E 1/4 CORNER, SECTION 31.
NEW	12 S	9 E	WM	34	NW NW	100 FEET SOUTH & 1500 FEET WEST FROM THE N1/4 CORNER, SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season from May 1 to September 15 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain a fish screen or by-pass device, as appropriate.

This certificate is issued to confirm AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered September 22, 2006, at Special Order Volume 70, Page 252, approving Transfer Application T-10032, and supercedes Certificate 27234, State record of Water Right Certificates.
