CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of HAT ROCK DRAIN DITCH, a tributary of COLUMBIA RIVER, for IRRIGATION of 108.5 ACRES.

This right was perfected under Permit 32000. The date of priority is September 14, 1966.

The amount of water to which this right is entitled is limited to an amount actually beneficially used for the described purposes and shall not exceed 1.955 cubic feet per second; if available at the original point of diversion located in the SW¼ SE¼, SECTION 21, T5N, R29E, WM; 920 FEET NORTH AND 1550 FEET WEST FROM THE SE CORNER OF SECTION 21, or the equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water to which this right is entitled is limited to an amount actually beneficially used for the described purposes and shall not exceed one-fortieth (1/40) of one cubic foot per second or the equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.
