CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TIM M. AND LINDA L. DERUWE  
412 GARDENA CREEK RD  
TOUCHET, WA 99360

confirms the right to use TWO WELLS in the PINE CREEK BASIN FOR THE PURPOSE OF PRIMARY IRRIGATION OF 6.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 171.5 ACRES.

This right was perfected under Permit G-10560. The date of priority is JUNE 10, 1985. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.83 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The points of appropriation are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to an appropriation not exceed 3.0 acre feet per acre per season.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
