confirms the right to use the waters of AN UNNAMED SPRING and SALMON CREEK, a tributary of the SOUTH FORK COQUILLE RIVER for DOMESTIC USE FOR ONE FAMILY, STOCK and IRRIGATION of 7.09 ACRES.

This right was perfected under Permit 44251. The date of priority is MAY 2, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.099 CUBIC FOOT PER SECOND (CFS); BEING 0.005 CFS FOR DOMESTIC USE FROM THE SPRING; 0.005 CFS FOR STOCK and 0.089 CFS FOR IRRIGATION FROM SALMON CREEK or its equivalent in case of rotation, measured at the point of diversion.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
