CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEBORAH JOHNSON  
7003 STEELHEAD PLACE  
GOLD HILL OR 97525

confirms the right to use the waters of ROGUE RIVER, tributary to the PACIFIC OCEAN for IRRIGATION of 0.5 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is SEPTEMBER 22, 1888.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.006 CUBIC FOOT PER SECOND, if available at the original point of diversion: TABLE ROCK DITCH: NE¼ NW¼, SECTION 6, T 36 S, R 1 W, W.M.; 333 FEET SOUTH AND 1987 FEET EAST FROM THE NW CORNER OF SECTION 6, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available at the original point of diversion.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.


**NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered January 24, 1991, at Special Order Volume 45, Page 66, approving Transfer Application 6426, and together with Certificate 65148 and Transfer Application 6293, supercedes Certificate 32743, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
