CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ROGUE RIVER, tributary to PACIFIC OCEAN for IRRIGATION of 1.30 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is SEPTEMBER 22, 1888.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.016 CUBIC FOOT PER SECOND (if available at the original point of diversion: TABLE ROCK DITCH – NE¼ NW¼, SECTION 6, T 36 S, R 1 W, W.M.; 333 FEET SOUTH AND 1987 FEET EAST FROM THE NW CORNER OF SECTION 6), or its equivalent in case of rotation, measured at the point of diversion.

The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
