## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JON H BOWERMAN GENERAL DELIVERY FOSSIL OR 97830

confirms the right to use the waters of JOHN DAY RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 24.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wheeler County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is FEBRUARY 1, 1909.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acrefoot per acre per calendar month; total of 5.0 acre-feet per acre for season, if available at the original point of diversion, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The quantity of water diverted at the new points of diversion shall not exceed the quantity of water available at the old point of diversion, located in the SE¼ SE¼, Section 22, T 8 S, R 19 E, WM; 1350 feet South and 450 feet West from the E¼, Section 22, under the subject right.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled. The type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered May 4, 1983, at Special Order Volume 37, Page 222, approving Transfer Application 5185, and supercedes Certificate 25129, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
