CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENT AND KEVIN DOERFLER 12333 SILVER FALLS HWY SE AUMSVILLE, OREGON 97325

confirms the right to use the waters of MARION CREEK, a tributary to the NORTH SANTIAM RIVER for IRRIGATION OF 1.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 38.0 ACRES.

This right was perfected under Permit S-27664. The date of priority is OCTOBER 16, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.01 CUBIC FOOT PER SECOND (CFS) FOR PRIMARY IRRIGATION AND 0.48 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
