 CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SOUTH FORK SPRAGUE RIVER, tributary to SPRAGUE RIVER for Livestock and Irrigation of 175 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Klamath County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 10, at Page 236. The date of priority is 1881. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.375 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, prior to June 15<sup>th</sup>, and ONE-EIGHTIETH of a cubic foot per second per acre after June 15<sup>th</sup>, with a total limitation of three acre feet per acre from March 1<sup>st</sup> to October 1<sup>st</sup> of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in point of diversion to reflect historic use and partial cancellation approved by an order of the Water Resources Director entered MAY 04 2009, at Special Order Volume 77, Page 685 approving Transfer Application T-10775, and supersedes Certificate 10000, State record of Water Right Certificates.

**NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
