CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM J. F. ASHWOOD
HAINES OR 97833

confirms the right to use the waters of ROCK CREEK, tributary to the POWDER RIVER for IRRIGATION of 200.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The dates of priority are APRIL 26, 1884 for 85.0 acres, JUNE 8, 1887 for 35.0 acres, APRIL 1891 for 80.0 acres, and MAY 1895 for 0.5 acre.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate correctly describes that portion of the water right confirmed by Certificate 82336, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUL 13 2009, approving Transfer Application 10600.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and said right shall be subject to all other conditions and limitations in said decree.
