CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO  
ORODELL DITCH ASSOCIATION  
LA GRANDE, OREGON 97850

confirms the right to use the waters of the GRANDE RONDE RIVER, a tributary to the SNAKE RIVER for IRRIGATION of 120.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1872. The use is limited to 3.0 acre-feet per acre in any irrigation season diverted at a rate of not to exceed ONE-FORTIETH of a cubic foot per second per acre; or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:
