CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES E. PERKINS 886 OAK STREET ASHLAND OREGON 97520

confirms the right to use the waters of A SPRING, TRICKLE CREEK (aka Dutch Gulch), AND PERKINS RESERVOIR, CONSTRUCTED UNDER PERMIT R-6439, TRIBUTARIES OF LITTLE APPLEGATE RIVER, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION of 1.1 ACRES.

This right was perfected under Permit 40397. The date of priority is FEBRUARY 10, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.015 CUBIC FOOT PER SECOND (CFS), BEING 0.005 CFS FROM THE SPRING FOR DOMESTIC, AND 0.01 CFS FROM TRICKLE CREEK AND PERKINS RESERVOIR FOR IRRIGATION, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
