## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CON LYNCH LAKEVIEW OR 97630

confirms the right to use the waters of HART LAKE, a tributary to WARNER LAKES and streams for SUPPLEMENTAL IRRIGATION of 1098.79 ACRES.

This right was perfected under Permit S-20854. The date of priority is MARCH 15, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 7.2 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
