CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EUGENE AND LORRAINE GRAVEL 2512 SE NORELIUS VANCOUVER WASHINGTON 98683

confirms the right to use the waters of AN UNNAMED STREAM, TWO RESERVOIRS, CONSTRUCTED UNDER PERMIT R-7790, AND FIVEMILE CREEK, TRIBUTARIES OF FIVEMILE CREEK, for IRRIGATION of 7.6 ACRES AND DOMESTIC USE FOR ONE FAMILY.

This right was perfected under Permit 43874. The date of priority is JUNE 22, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.105 CUBIC FOOT PER SECOND (CFS); BEING 0.10 CFS FROM THE UNNAMED STREAM AND RESERVOIRS with any deficiency in the available supply to be made up by diversion of water from Fivemile Creek FOR IRRIGATION AND 0.005 CFS FROM FIVEMILE CREEK FOR DOMESTIC USE, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
