CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MIDDLE FORK MALHEUR RIVER, tributary to SNAKE RIVER for IRRIGATION of 144.0 ACRES in Tract 1.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Harney County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 228. The date of priority is 1885.

The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 1.5 acre feet per acre in any 30-day period prior to June 1st, and 1.0 acre foot per acre in any 30-day period after June 1st of each year, or 3.0 acre feet per acre during any season, diverted at a rate of not to exceed ONE-TWENTIETH of a cubic foot per second per acre, and shall be subject to all other conditions and limitations contained in said decree.

The point of diversion is located as follows:
