CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHESTERFIELD B. PARKER AND LELAND S. PARKER
PAISLEY, OREGON

confirms the right to use the waters of Chewaucan River, tributary of Abert Lake, and Elder Creek, tributary of Chewaucan River, for irrigation of 261.33 acres, domestic and stock use.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Lake County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at page 1. The date of priority is 1879 under Proof No. 54, 1878 under Proof No. 55 and 1897 under Proof No. 56.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1/25 CUBIC FOOT PER SECOND PER ACRE, and shall be further limited to the aggregate quantity in acre feet per acre irrigated during the irrigation season, being the period of April 1 to September 15 of each year, as set forth for each proof described below; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate corrects the priority date for Proof No. 54 and describes that portion of the water right confirmed by Certificate 3629, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered November 28, 2005 approving Transfer Application T-9733.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
