confirms the right to use the waters of A WELL, within the BUTTER CREEK BASIN for SUPPLEMENTAL IRRIGATION of 0.4 ACRE.

This right was perfected under Permit G-3816. The date of priority is September 11, 1967. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.005 cubic foot per second, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted.
